



# Collector Sale Terms and Conditions

## CONDITIONS FOR REGISTRATION

1. All tenders must be placed in sealed A4 size envelopes and forwarded to:

2. Tenders will only be accepted if provided on the specified form. Verbal tenders will not be considered.
3. **Lodgement of tenders will close on the 03<sup>rd</sup> July, 2015, 16:06pm.** Bidders must ensure that their tender is received by Customs by the due date because late submissions will not be considered.
4. Interested bidders are required to **strictly raise a Bank Cheque of K5, 000.00 as registration to the Seized Goods Trust Account and present the cheque at the Customs office, ground floor. Do not pay registration directly into the Trust Account. No cash payments will be entertained.**

5. Unsuccessful bidders must produce the original receipt to Customs to get registration refund. Customs will not be liable to pay any costs associated to raising bank cheques or any other costs of that matter.

## CONDITIONS FOR COLLECTOR SALE

6. All interested bidders must take note that the **Container is not on sale, only the goods inside the container are on sale.** Bidders can only tender for the goods in the respective container only.
7. Customs reserves the right to withdraw any container or vehicle from the sale at any time during the tender process.
8. Customs reserves the right to accept or reject any tender submission.
9. All bidders shall be deemed to have submitted their tender having consideration of a physical inspection. Bidders must ensure to inspect the container contents or vehicle at the time and date specified in PNG Customs advertisement. No alternative inspection times will be available.
10. Appropriate, fully enclosed footwear must be worn during inspection. PNG Customs and its contractor reserve the right to refuse entry to the holding yard if footwear is not considered suitable.

11. Customs will not take any responsibility for changes to the condition of any container or vehicle following inspection.
  12. Customs does not warrant the conditions of the container goods or vehicles in any way as all container goods and vehicles are sold on an ***“As is where is basis”***.
  13. Information received from any other Customs officer may not be accurate and will not be binding upon PNG Customs.
  14. No representation made by or on behalf of PNG Customs shall be binding on PNG Customs unless that representation is in writing.
  15. Lobbying or canvassing with Customs officers or staff during this process may be cause for disqualification from consideration.
  16. Customs duty and tax shall be applicable on the container goods and vehicles. Bidders are hereby informed that different goods and vehicles classifications attract different duty rates.

#### **CONDITIONS FOR SUCCESSFUL BIDDERS**

17. All successful bidders will undertake the responsibility for organising and paying cartage fee for awarded goods.
18. All successful bidders of goods must ensure to unstuff the awarded goods from the container and return the container within seven (7) days from the time the container is released to your premises.
19. All successful bidders shall be required to sign a legal document with the respective shipping agency to ensure the safe and timely return of container to the shipping agency storage facility.
20. Storage fees will incur after the seven (7) days lapse.

#### **SPECIAL NOTE**

By submitting this Tender form, the bidder warrants and represent that it has made its own enquiries and investigations and has obtained professional advice and all other relevant information so as to inform itself of all risks and contingencies which may affect its Tender price.

Bidders are encouraged to fully investigate so as to satisfy themselves that there is no encumbrance on the goods or vehicle they wish to tender for.
